fee vide reference 2nd cited.

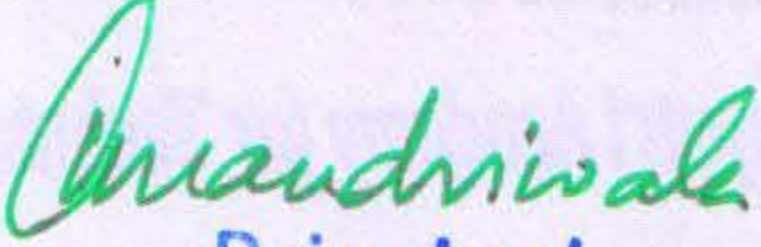
2) The No Objection Certificate for Occupancy Certificate was issued vide

Institutional Occupancy.

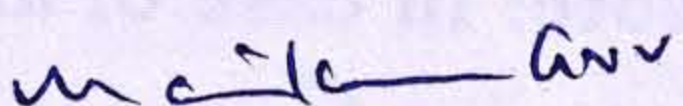
3) The management has submitted the self-Certification report and stated that

information provided is false, they understand that Renewal NOC deemed may be
cancelled by the concerned authority. Further, they undertake to maintain the
installed Fire Safety measures in good working condition at all time. Further, the
Management has provided 2HP Motor with triplex pump at ground floor and
alternative upper floors by connecting to the normal water plumbing system.

4) In view of the above and taking into consideration of the larger public
interest and in the context of the COVID-19 pandemic across the country and also
based on the self-certification submitted by the management, the Renewal of No
Objection Certificate is issued to the existing building of M/s International DELHI
Public School, Tadepalligudem, West Godavari District with Ground + two upper

5) **Fire Safety Suggestions:**

Sl. No.	As Builder	As Occupant	As Security personnel
1.	All the fire protection arrangements shall be maintained in good condition as seen during inspection.	The escape / exit routes shall not be kept locked / blocked or encroached.	All the occupants must know the correct method of operation of the fire fighting system installed
2.	Any loss of life or property due to non-functioning of fire safety measures and other installations shall be the responsibilities of the management.	All occupants shall be trained to operate the fire safety equipment during emergency.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.
3.	Addition / alteration, if any in the building may be verified by building authority.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.	All security personnel shall be trained to operate the fire safety equipment during emergency.
4.	This Annual Periodical Renewal Fire Certificate is only from Fire Safety Point of View.	Raise the alarm if the fire cannot be controlled, evacuate the area completely at once with nearest safe exit.	Attack the fire using available fire equipment only if you feel capable of controlling it. If not, takes all steps to isolate the area by closing doors and windows.

6) This Renewal of No Objection Certificate is valid for a period of Five years from the date of issue of this letter vide G.O.Ms.No 90 Home (Prisons & Fire) Department Dated:13-08-2021 (Revised Periodicity). The owner/ Occupier/ Builder/Management concerned of the building shall submit self declaration/ Certification every year in the prescribed format and submit / Upload the photographs of the Mock drills conducted in the premises. It is the responsibility of the builder to maintain the Fire Safety Equipment in good working condition at all times and apply for next Periodical Renewal of No Objection Certificate, duly remitting the User Charges as per G.O.Ms.No.140 Home (Pri. & Fire Services) Dept., Dated:04-09-2015, two (2) months before expiry of this Renewal of No Objection Certificate.

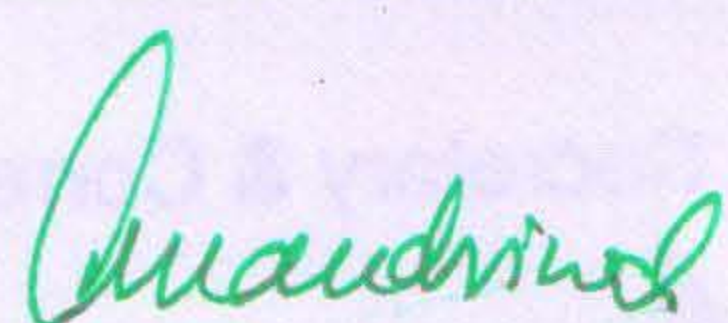

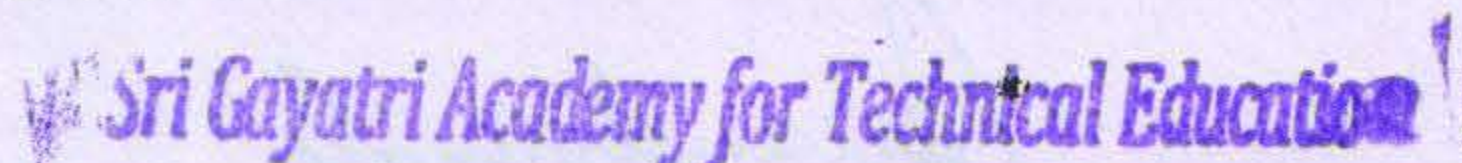

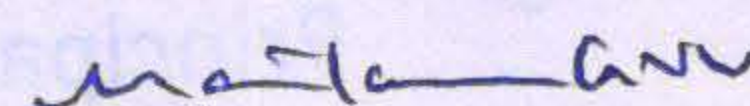
